RESOLUTION No.2/2023 DATED 17.08.2023

The Hon'ble High Court, Madras vide Order dated 12.07.2023 in the W.P. No. 40172 of 2015 and WMP No. 21578 of 2016 held that the entire process of public appointment notice issued in "Dinamani" daily newspaper dated 28.10.2015 in Villupuram edition and its consequential appointment of Daily Rated Casual Labourers (CLRs) as Multi-purpose Workers vide Order dated 07.12.2015 are declared as illegal.

The DP & AR to whom the matter was referred for views has opined that with the quashing of the appointment notice dated 28.10.2015 and declaring their consequential appointment as Multipurpose Worker on 07.12.2015 as illegal, they have no right to continue in the post. Having already vacated the engagement as casual labourers, their continuation in that capacity (as casual labourers) is not automatic and any such engagement has to be treated as fresh engagement only. Opinion of the Law Department may also be taken in this regard.

The Law Department has opined in this regard that as no appeal has been preferred against the said order, the same has attained finality and binding on the official respondents.

The implication of the Order was discussed threadbare in the Board Meeting in the light of G.O.Ms. No. 22 dated 27.02.2009 of DP&AR (PW), Puducherry and opinion of DP&AR, the Board is of the view that an appeal to the Order dated 12.07.2023 of Hon'ble High Court of Madras could not be preferred.

It is therefore resolved that the Order of appointment issued vide Memorandum dated 07.12.2015 and Office Order dated 29.12.2015 as Multipurpose Workers to the candidates detailed in the annexure are cancelled and their services are terminated with immediate effect in compliance of Order dated 12.07.2023 of the Hon'ble High Court of Madras in the W.P. No. 40172 of 2015 and WMP No. 21578 of 2016.
